	6.	This certificate should not be regarded as a formal approval under the building warrant process prescribed by the Building (Scotland) Act 2003 enacted from 1 May 2005

7. Fairhurst Consulting Engineers statement dated 25/01/2023 Type C-Rev 5 referenced here under Section G, confirm that a structural appraisal has been carried out. Further site-specific information MUST BE made available when a site-specific building warrant is sought. Such additional information should take cognisance of Procedural Guidance on Certification including information to be submitted with a Building Warrant Application dated April 2010 Version 2. Confirmation of a holistic approach to structural adequacy of the entire completed building shall be provided by a registered engineer to the local authority within whose area the site-specific dwelling is to be built.

<p><b>Technical Standard 4.3 Stairs and ramps (Non Domestic)</b></p> <p>Every building must be designed and constructed in such a way that every level can be reached safely by stairs or ramps.</p> <p><b>Guidance clause 4.3.12 Ramp landings</b> requires a landing to be provided at the top and bottom of every flight.</p>	<p><b>Dispensation of this requirement is considered reasonable based on the following:</b></p> <ol style="list-style-type: none"> <li>1. This dispensation only applies to the requirement for a landing to the top of the access ramp serving the rear doors to the DRS housing (where a ramp is required due to site specific conditions).</li> <li>2. The clear width of the ramp will be at least the same width as the doors.</li> <li>3. The ramp shall have a maximum gradient of 1:15.</li> <li>4. The ramp will not be used by members of the public.</li> <li>5. Use of the ramp to access the rear of the DRS housing will be subject to appropriate risk assessments and management / operational procedures developed by Sainsbury's.</li> </ol>	<p>Where a site dictates the need for a ramp, the layout shown in the supporting drawings and specifications shall be accepted by the verifier.</p>
